- **Original high school diploma, G.E.D. or original transcript in a sealed envelope from the educational institution. Absolutely no copies will be accepted. If you have a transcript, DO NOT make a copy, copies will be made when you apply.**
- **Be at least 18 years of age**
- **Cashier's check or money order in the amount of \$25.00 made payable to IBEW Local 9 Apprenticeship Fund. NO personal checks will be accepted.**

Study Guides will be available for \$15.00. Please bring a separate cashier's check or money order. NO personal checks or cash will be accepted.
